- Nonrefundable Registration Fee (\$150): Applies to new students and late registrations. Returning students must register by June 25 to avoid the registration fee.
- Supply Fee (\$400). Required for all students. For returning students, payment reserves the student's seat for the following school year. The supply fee is refundable until August 10th.
- Tuition payment is calculated starting from the current marking period. No partial credit given for past unattended portion of the current marking period.
- Signing this contract and/or paying the deposit does not preclude administration from refusing re-enrollment of any student after a disciplinary and/or academic review.
- All tuition payments must be completed by April 1 of the academic year.
- **New student enrollment begins May 1. Some classes are at full capacity; current student families who do not submit this form by May 1 may lose their seat.**

I understand and agree to the terms and conditions of the tuition. I agree to pay tuition in a timely manner. Late payments will incur a \$25 late fee. If it exceeds 2 months, my child may be denied access into the classroom and may lead to them being unregistered from the school. I understand that the initial 15% tuition is due by August 1.

SCHOOL CONTRACT

I, _____, parent/guardian of _____, acknowledge that participation in school programs, activities, athletics, field trips, and related events involves inherent risks, including injury, illness, or property damage. By enrolling my child at Andalusia School, I voluntarily assume these risks. To the fullest extent permitted by law, I agree to release and hold harmless Andalusia School, MAS-UNY, and their officers, employees, and volunteers from any claims or liabilities arising from my child's participation, except in cases of gross negligence or willful misconduct.

As parent/guardian of student, I understand and agree that student's admittance and continued enrollment in the school is conditional on good behavior and adherence to school discipline, ethical, and anti-bullying policies. Student is subject to suspension and/or expulsion if any school policy is violated as determined at the sole discretion and judgment to the school administration. I understand that suspension and expulsion may occur as a result to several incidents or from just one incident depending on severity. I agree to cooperate with the school administration and staff in resolving and behavioral problems brought to my attention, and that my lack of cooperation, inability to attend counseling, failure to comply with commitments on my part or the part of the student are also grounds for suspension/expulsion at the sole discretion of a judgment of the school administration.

I understand that regular attendance is required. Excessive lateness and absence may result in student not meeting grade level standards and not passing their grade and/or class. I understand that if my child is absent from school for more than 10 straight days, they will be unregistered from the school, except in the case of medical emergency.

By signing, I confirm that I have read and understood this agreement and accept its terms.
